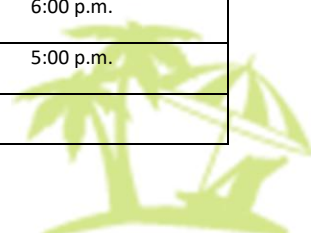
Passport Required
